Life Insurance Corporation of India The Government of India has decided to exercise the oversubscription option for 50.59 crore equity shares, representing a 4 percent stake in Life Insurance Corporation of India (LIC), through an offer-for-sale (OFS) on August 5. This is in addition to the base issue size of 31.62 crore equity shares, representing a 2.5 percent stake. Dredging Corporation of India shares in focus after Q2 swings to profit; revenue jumps 47% .
