Container Corporation of India The Board of Directors has appointed Ajit Kumar Panda as Chairman and Managing Director (CMD) of Container Corporation of India, effective August 1, 2026 .Dr Reddy's Laboratories The company has received approval from the US Food and Drug Administration (FDA) for Rituximab, a biosimilar to Rituxan, for the US market. Rituximab is widely used to treat several B-cell malignancies, including non-Hodgkin lymphoma and chronic lymphocytic leukemia, as well as certain autoimmune conditions.
