With this acquisition, SDPL has become a wholly owned subsidiary of the company. This acquisition is part of the company's growth strategy to build a robust pipeline of new launches and expand its presence in the key markets of Bengaluru. Western Carriers India The logistics and supply chain solutions provider has secured an EXIM logistics contract worth Rs 230 crore from Jindal Stainless. The contract spans a period of three years.
