Post this transaction, the company's shareholding in Tata Steel Colors has increased from 99.99 percent to 100 percent, and accordingly, Tata Steel Colors has become an indirect wholly owned subsidiary of the company. Poonawalla Fincorp The company has launched its qualified institutional placement (QIP) issue on April 9. The floor price for the offer has been fixed at Rs 390.26 per share.
